At 64 Million Artists we believe everyone is creative. Whether you consider yourself creative or are beginning your journey with creativity, we welcome you to join us. In this community we strive to create positive and welcoming spaces for discussion, encouragement and connection.

SAFETY

We will not tolerate any hate speech, bullying, or rude and prejudiced comments in the group. This includes, but is not limited to, discrimination against the <u>protected characteristics</u>:

age / disability / race / gender / marriage and civil partnership pregnancy and maternity / religion or belief / sex / sexual orientation

If you see or receive an offensive comment, please report it and we will usually take the following steps:

- Delete the comment from the group.
- Give a warning to the person who made the comment and explain why it is inappropriate.
- If necessary, remove the person from the Facebook group.
- We will always try to give feedback on why we've removed posts or people from the group.



SHARING & PARTICIPATING

- This group is a place for participants to share their responses to The January Challenge and The Weekly Challenge, and the creative endeavours that come with that. <u>This group is not a place to sell work</u> <u>or promote a service or event.</u> Your post will be removed if it is not relevant to the group topics.
- Be mindful of what you post, we all have different experiences and stories that you may want to share with your challenge response. But please be aware of sensitive topics that you may be including and the effects it could have on others. <u>Consider including a content warning in</u> <u>your post if you discuss sensitive topics</u> i.e body image, abuse, violence.
- Authentic, expressive discussions make groups great, but may also be sensitive and private. Social Media is a public space, although this group is private, please be wary of what you are comfortable sharing with a large online community, and <u>please do not share any sensitive personal details such as email addresses, phone numbers and home addresses.</u>
- 64 Million Artists share challenge responses on Instagram, Twitter and in their newsletter. When posting in this group you give permission for 64MA to repost the challenge response including the image shared and caption. If you do not wish for any of your responses to be shared via the 64MA social media, please make it known in your post.
- Our challenge programmes promote everyday creativity and the positive impact it can have on our wellbeing when we take part. Although this group exists to provide encouragement and connection through creativity, please note we cannot offer emotional support in the group.
